## School Governing Body - Parent Governor Election

There is one vacancy for a Parent Governor to serve on the Governing Body of Saint Paul's Catholic High School.

The powers and responsibilities of Governors require Governors to act in a strategic role for the school and be accountable for their responsibilities. The role requires you to:

- Help to decide the priorities for improving the school
- Make yourself available to parents, listen to other parents' opinions and take account of them as you contribute to governors' decisions
- Work in partnership with the Headteacher, Senior Leadership team and co-operatively with other Governors to raise standards and improve outcomes for all children
- Prepare for meetings by reading papers beforehand

Parents have much to offer to their local schools and can play a vital part in helping schools to meet the needs of the children and communities they serve.

Some parents may feel that they do not have the necessary expertise, knowledge or skills to carry out the role effectively, however, it is very important that parents stand for election to the Governing Body so that the views of parents are represented on it. Otherwise, a parent may be appointed to serve who has no children in your child's school and who knows very little about the school and its local community.
